

Troop Bonus Proceeds Criteria 2023 Cookie Program

Troops that meet the criteria below will qualify to earn bonus proceeds from the 2023 Cookie Program. PGA = Per Girl Average (Selling)

Troop participation in the Fall Product Program (as relates to bonus proceeds) is defined as:

Participation in the Fall Product Program means actually taking part in the sale to get the benefit of learning about salesmanship, safety, money handling, etc. A troop must complete the following to be considered a participating troop:

- 1) Provide Fall Product Program training to both parents and girls.
- 2) Set a troop sales goal.
- 3) Sell at least 12 items.
- 4) Follow all other guidelines/deadlines/policies, etc. set forth for the program.

Troops are not eligible for bonus proceeds if:

- They have only one girl participating in the program.
- They do not report ALL Cookies for a Cause sales.
- They submit a Troop Unpaid Funds Form for an ACH deferral and the deferral is more than 50% of amount due to the council for any ACH withdrawal.
- They request more than one ACH deferral.
- An ACH withdrawal is rejected due to insufficient funds or a closed account.
- They have a balance due to the council on April 7, 2023.
- A council staff member receives a complaint(s) about girl (or volunteer) behavior at a cookie booth.

- The troop inventory of cookies is not allocated to girls via troop-to-girl transfers in Smart Cookies by Troop Cookie Manager established deadline.

The bonus proceed payments will be made via ACH deposit directly to the troop account on May 19, 2023.

Troops that submit Girl Unpaid Funds Form(s) will not receive the bonus until AFTER the unpaid funds form(s) has been processed. Troop will not receive the bonus proceeds on number of packages sold by girl (that has outstanding amount due as of processing date of ACH deposit).

PGA selling will not be rounded up. (For example – a PGA selling of 199.79 packages will not round up to a 200 PGA selling.)

Girl Scout Troop 890123:

- Had a per girl average selling of at least 330 packages for the 2023 cookie program
- Increased the number of packages sold over the 2022 cookie program
- Increased its PGA by 333 packages over the 2022 cookie program
- Participated in the Fall Product Program

They will receive an additional \$.15 per package sold for the 2023 cookie program. If they had not participated in the Fall Product Program, they would only receive \$.10 per package sold.

3,891 packages X \$.15 = \$583.65

3,891 packages X \$.10 = \$389.10 (without participation in the Fall Product Program)

Girl Scout Troop 890123 will receive bonus proceeds in the amount of \$583.65.
